Undertaking by Parents and Guardians on the Admission of Pupils to the above School

As a pupil at Leicester Islamic Academy ("The School"), I/we being the parent(s) of the Pupil, do hereby jointly and severally:

Agree and undertake with the Academy as follows:

1. THE FEE

I undertake to pay prescribed fee fixed for the year (on the first day of each term in advance or by ten monthly instalments by Bankers Order payable from the first day of the Academic year).

2. ATTENDANCE

That unless prevented by sickness or other reason satisfactory to the Academy, the Pupil will regularly attend the School and strictly conform to the Rules and Regulation of the School for the time being in force.

3. RULES AND REGULATIONS

I/We on my/our part will conform to the before mentioned Rules and Regulations in so far as the same affect us as Parents/Guardians and are notified to us.

4. UNIFORM

School Uniform will be worn during School hours and journeys from home to School and return.

5. NOTICE

(a) I/We will give not less than a month's notice in writing before removing the Pupil from School whether before, at or after the end of the School year in which he/she finishes primary education (Year 6). Such notice will be given not later than the last day of one month to take effect at the end of the subsequent month.

(b) In default of me/us giving notice as required, I/we shall pay in full on demand a month's tuition fees in lieu of notice.

6. CONTINUATION OF TUITION

It is my/our firm intention that the Pupil will not cease to be a Pupil at the School until the end of the School year in which he/she finishes primary education (Year 6).

The Aims of the Leicester Islamic Academy:

1. To ensure that the curriculum meets the needs of all pupils
2. To provide a safe and welcoming environment where each person has respect for themselves and others
3. To encourage all pupils to develop a positive self-image
4. To promote understanding and acceptance of others whatever their ability, belief, ethnic origin, gender, race or social background.
5. To prepare our pupils for life in a society which respects cultural variety
6. To provide all pupils with a core of religious, social, linguistic, mathematical, scientific, technological, geographical, political, economical and physical knowledge and skills.

Acknowledge and Confirm that the Academy reserves the right, namely:

1. UNPAID FEE

If at the beginning of a term any Fees or other monies due in respect of the Pupil remains unpaid, whether in respect of that term or any previous term, the Pupil may be refused admission to the School until such Fees are paid. The exercise of this power will not affect my/our liability for payment of the outstanding fees, nor, in the absence of the stipulated notice of withdrawal, will I/we be deemed to have withdrawn the Pupil.

2. MISCONDUCT

To demand the Pupils immediate withdrawal without notice in case of serious misconduct without any obligation upon the Academy to make any refund of fees already due or paid.

3. STANDARDS

To terminate the Pupils attendance in the event of his/her failing to maintain the General or Academic Standards required by the Head Teacher. In this latter case, at least one terms notice will be given by the Academy.
